Public offer to conclude a contract of donation

1. The value of this public offer

- 1.1. This public offer ("Offer") is an offer Latvia Renaissance Foundation, the details of which are listed in Section 5 of the Offer, to conclude with any person who responds to an offer ("contributors"), a donation agreement ("Agreement"), on the terms provided below.
- 1.2. The Offer is a public offer in accordance with the Civil Law of the Republic of Latvia.
- 1.3. Offer comes into effect from the day following the day of placing it on the website in the Internet at http://www.latvia-renaissance.foundation ("WebSite").
- 1.4. Offer valid indefinitely. Latvia Renaissance Foundation has the right to cancel the Offer at any time without explanation.
- 1.5. The Offer can be amended and supplemented, which shall enter into force on the day following the day of their placement on the WebSite.
- 1.6. The invalidity of one or more conditions of the Offer does not imply the invalidity of all other conditions of the Offer.
